

The Board of School Trustees of the Centerville-Abington Community Schools met at 7:00 p.m. The following members present via Zoom: Renee Westover, Susan Hamilton, and Todd Duke. Brad Lambright was present from the board room. Andy Wandersee was absent. The meeting was opened with the Pledge of Allegiance to the Flag of the United States of America.

Motion by Renee Westover, second by Todd Duke, to approve the consent items as presented. Those voting in favor were: Todd Duke, Renee Westover, Susan Hamilton, and Brad Lambright. There were no votes against. Documentation follows.

Brad Lambright opened the floor to community comments. There were no comments and the floor was closed by Mr. Lambright.

The Board of Trustees recognized Thomas Hamilton on his retirement from Centerville-Abington Community Schools after 44 years of teaching in area schools. Motion by Susan Hamilton, second by Renee Westover, to approve a resolution honoring Thomas Hamilton for his service and retirement from Centerville-Abington Community Schools as read. Those voting in favor were: Todd Duke, Renee Westover, Susan Hamilton, and Brad Lambright. There were no votes against. Documentation follows.

The Board of Trustees recognized Bill Lewis for being selected Centerville-Abington Community Schools 2020 Teacher of the Year. Motion by Todd Duke, second by Renee Westover, to approve a resolution honoring Bill Lewis for being selected Centerville-Abington Community Schools 2020 Teacher of the Year as read. Mr. Campbell gave an update on the food distribution to students during the COVID-19 pandemic. He reported that the final distribution occurred on May 20, and a total of 16,475 breakfasts and 16,430 lunches were served.
